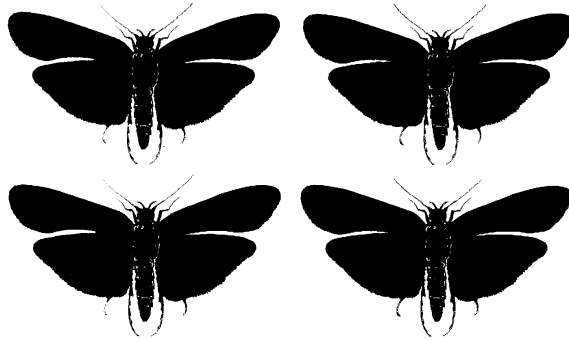

Grain storage areas.	Moths	50mL per 100m <sup>3</sup>	Apply regularly when pests are active. Apply undiluted through fogging or misting equipment or conventional hand operated sprayers. Spray must be finely atomised to ensure even distribution and penetration throughout the premises being treated. Keep windows and doors closed during and for at least 30 minutes after application.

**GENERAL INSTRUCTIONS:** DO NOT apply to grain or foodstuffs. DO NOT mix with cereal grains. For grain handling authorities, only for the treatment of grain storage facilities. This product is specially formulated for use through misting or fogging equipment or conventional hand operated sprayers. Avoid contamination of food.

**PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT:** DO NOT contaminate streams, rivers or waterways with the chemical or used containers.

**STORAGE AND DISPOSAL:** Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Triple or preferably pressure rinse containers before disposal. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit. Empty containers and product should not be burnt.
